The position to be filled is a four year term ending December 6, 2024.

The seat will be subject to election in the general election in November, 2024.

The District board has 60 days from the date the board is notified of the vacancy or the effective date of the vacancy, whichever is later, to fill the vacancy by appointment or by calling a special election. (Cal.Gov.Code §1780(d)(1))

Pursuant to Government Code §1780(d)(1), this notice will be posted for 15 days in 3 or more conspicuous locations in the District between July 3, 2021 and July 19, 2021.
